Kev Sib Pauv Cuab Yeej Ntiag Tug

Qhov yuav tsum tau ua thib ib ntawm kev sib pauv 1031 yog qhov kev khaiv lag luam ntaww yuav tsum ua li ib qho kev sib pauv tsis yog ua li ib qho kev muag thiab ua li kev muas. Txhawm rau ua kom tiav li no, yuav tsum muaj ib tug tim khawv los cuam tshuam nrog rau qhov khoom cuab yeej uas rho tawm (khoom cuab yeej muag tawm) thiab qhov khoom cuab yeej uas tau los (khoom cuab yeej tau los). Xyuas kom meej tias qhov kev khaiv lag luam ntaww yog li ib qho kev sib pauv, tsis yog ua li kev muag thiab los yog ua raws kev muas, tus kws nqis peev yuav tsum tau kos ib daim ntaww sib yeem sib pauv, ib daim ntaww cog lus txog kev muas, thiab lwm yam ntaub ntaww ua ntej thaum cov khoom cuab yeej muag tawm, thiab tus tim khawv yuav tsum tuav cov nyiaj tau los txog rau thaum uas muab coj mus yuav dua ib co khoom cuab yeej los nyob chaw. Yog thaum uas cov ntaub ntaww raug ko npe lawm, tus tim khawv tsis tas yuav rau npe rau cov khoom cuab yeej.

Qhov uas yuav tsum tau muaj ntawm Like-Kind

Txhawm rau ua kom raws li kev ncua sib hawm se, tus neeg them se uas muag cov khoom cuab yeej tawm yuav tsum muas cov khoom cuab yeej los nyob chaw. Raws li qhov qauv no, yog tias lub Tuam Txhab B muag ib Yam khoom cuab yeej tawm lawm, lub Tuam Txhab B ntawv yuav tsum tau ib qho khoom cuab yeej los nyob chaw thiab. Ib qho uas raug tshwj cia ntawm qhov cai uas yuav tsum tau muaj ntawv yog kev koom siab uas tsis hais txog lub hom phiaj them se, xws li cov tuam txhab uas muaj thwj tim lav ib tug xwb thiab muaj kev ntseeg siab. Sij hawm thiab kev taw qhia

Tus kws nqis peev muaj sij hawm 45 hnub ntawm hnub kawg ntawm yam khoom cuab yeej uas rho tawm lawm los tshawb saib qhia yam khoom cuab yeej uas los nyob chaw. Kev tshawb taw qhia khoom cuab yeej uas los nyob chaw yam ua tib zoo yog ib qho uas yuav tau ua rau kev sib pauv uas siv tau, thiab tus kws nqis peev tsuas muaj peev xwm yuav tau yam khoom cuab yeej uas twb raug xaiv tib zoo los ntawm lub sij hawm xaiv qhia 45 hnub. Cov vaj tse hloov chaw uas tau los (Raws li tias, twb kaw lawm) nyob rau lub sij hawm 45 hnub raug xam hais tias twb raug tshawb qhia yam tib zoo lawm. Nyob li ntawm lub vaj tse uas tsis tau muas los nyob rau lub sij hawm 45 hnub ntaw, qhov kev tshawb qhia yuav tsum piav qhia yam khoom ntaw (nrog rau chaw nyob los yog piav qhia yam raug kev cai), thiab yuav tsum sau ua ntaw, ko npe ntawm tus kws nqis peev thiab xa ua ntej ib tag hmo ntawm hnub thib 45. Yog hais tias cov khoom cuab yeej uas rho tawm ntaww nws raug nyob ua pawg ua ke nyob hauv tib qho kev sib pauv xwb, lub sij hawm 45 hnub yuav pib khiav txij li thaum hnub uas kaw ntawm lub vaj tse xub thawj. Yog thaum txoj cai escrow kaw cov khoom cuab yeej uas rho tawm lawm, tus kws nqis peev muaj sij hawm tsawg dua 180 hnub ntawm hnub kaw los, los yog hnub ntawm uas tus kws nqis peev li se them rov ntawm cov khoom cuab yeej uas rho tawm raug muag tawm, txhawm rau kaw kev lag luam muas khoom thiab ua kom tiav qhov kev sib pauv. Nyob li ntawm kev kaw kev sib pauv nyob rau hnub kawg ntawm xyoo, tus neeg them se yuav tau ncua txhawm rau ntawv rau nws li se uas them rov kom tau 180 hnub kiag.
